+ Federal Funds Effective Rate : The interest rate at which depository institutions lend balances among each other overnight at a Federal Reserve district bank. This interest rate is managed by the Federal Reserve and set daily by the market.

+ S&P LGIP Index : Standard and Poor's Corporation created a local government investment pool ( LGIP ) Index in March 1995. Currently the Index is comprised of 50 plus LGIP's rated AAAm or AAmm ( Their highest ratings ). The rate shown is the monthly average of the 7- Day yield.
