+ S&P LGIP Index : Standard and Poor's Corporation created a local government investment pool (LGIP) Index in March 1995. Currently the Index is comprised of 50 plus LGIP's rated AAA or AAM (Their highest ratings). The rate shown is the monthly average of the 7 - Day yield.
