+ Federal Funds Effective Rate : The interest rate at which depository institutions lend balances among each other overnight at a Federal Reserve district bank. This interest rate is managed by the Federal Reserve and set daily by the market.

+ S&P LGIP Index : Standard and Poor's Corporation created a local government investment pool (LGIP) Index in March 1995. Currently the Index is comprised of 50 plus LGIP's rated AAAm or AAmm (Their highest ratings). The rate shown is the monthly average of the 7- Day yield.
