+ S&P LGIP Index : Standard and Poor's Corporation created a local government investment pool ( LGIP ) index in March 1995. Currently the index is comprised of 50 plus LGIP's rated AAAM or AAAM ( Their highest ratings ). The rate shown is the monthly average of the 7- Day yield.
